Our Program, "Kids First" has been developed to meet the needs of parents who are sharing parenting between two homes. This 4 hour Family Stabilization program puts parents on the path to minimizing negative effects for themselves and for their children. This course meets the requirements of the Texas Family Code 105.009 and was the **Original** Program of its kind.

With over twenty years providing parents skills to help their children, Kids First has updated the program to meet the needs of divorcing parents, never married parents, and grandparents.

Our four-hour class is the most comprehensive court mandated parenting course available. A Parent guidebook, (available in Spanish), videotaped segments, group discussions and hypothetical situations keep participants actively engaged and maximize their learning. The emphasis is on what parents can do proactively to circumvent negative consequences for their children. Mental health professionals with expertise in parenting, the impact of divorce on children, and child custody issues present parenting relationships along a continuum from parallel parenting to cooperative parenting. Evaluation results have been overwhelmingly positive. A certificate of completion is received at the end of the class.
